Executive Summary

The March 18, 2018 Special District Board Meeting was called to order at 10:00 AM by Kiwanis Family and Foundation Chair Ana Chavez.

Removal of District Governor, Lawrence Sahagun, effective immediately after closing session of District Convention, which means that on the behalf of Circle K, he cannot attend any Kiwanis Family-related events including but not limited to Key Club and KIWIN'S District Conventions, Spring Training Conference, and International Convention (CKIx). Additionally, he will not be allowed to apply for the Distinguished District Governor Award for CKIx, will not receive the William A. Dunlap Award if awarded, will not have a retirement speech at closing session of District Convention, and will not take part of any of the District Convention awards responsibilities including but not limited to taking pictures with recipients and presenting awards.

District Administrator Camille Goulet restated the motion of removing District Governor Lawrence Sahagun after the closing session of District Convention, which will prevent him from attending any events thereafter, such as Key Club and KIWIN'S District Conventions, Spring Training Conferences, and International Convention, on the behalf of Circle K. He will also not be allowed to apply for the Distinguished District Governor Award for International Convention, be stripped of receiving the William A. Dunlap Award, not have a retirement speech at closing session of District Convention, and not take part in any District Convention awards responsibilities including but not limited to taking pictures with award recipients and presenting awards.

Capital Lieutenant Governor David Duy Ngo so moved. Seconded by Central Coast Lieutenant Governor Bill Truong.
